OPERATIONAL CHARTER

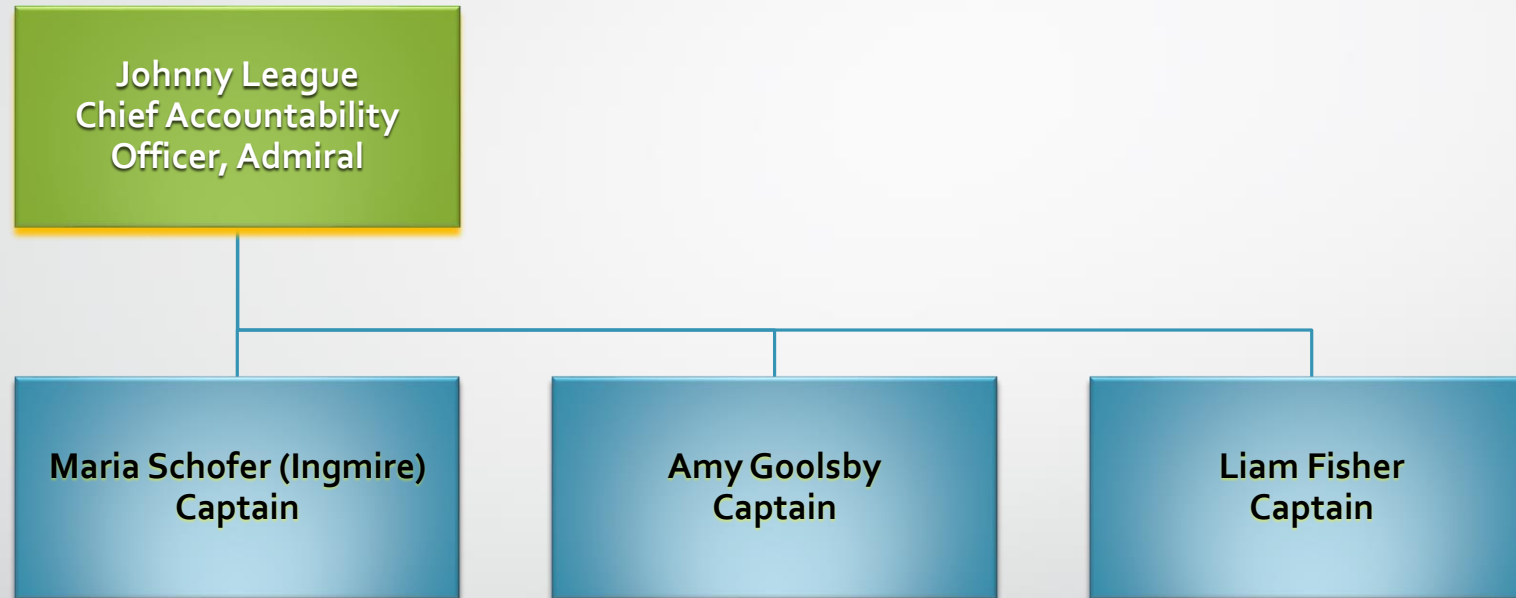
- METRO ATLANTA GEEKS, HEREAFTER KNOWN AS MAG, IS A FRATERNAL ORGANIZATION CREATED FOR THE EXPRESS PURPOSE OF COMMUNITY AND INDIVIDUAL SERVICE.
- AS OF AUGUST 1, 2019 THIS ORGANIZATION WILL BE OFFICIALLY LED BY A TEAM OF THREE CAPTAINS WHO WILL BE CHARGED WITH THE DIRECTION, LEADERSHIP, AND ADMINISTRATION OF MAG; AS WELL AS ALL APPLICABLE LEGAL AND FINANCIAL RESPONSIBILITIES.
- A BOARD OF DIRECTORS WILL BE SELECTED BY THE EXECUTIVE TEAM WHICH WILL BE CHARGED WITH THE EXECUTION OF TASKS AND DIVISION OF LABOR ACROSS THE ENTIRE ORGANIZATION.
- AN ADVISORY COMMITTEE WILL BE FORMED BY THE EXECUTIVE TEAM TO ASSIST THE LEADERSHIP WITH VISION AND PROGRESS OF THE ORG AND ALL ONLINE PLATFORMS.
- JOHNNY LEAGUE, THE FOUNDER OF MAG, WILL BE KNOWN AS LIFETIME SUPREME ADMIRAL. HIS CHARGE AS CHIEF ACCOUNTABILITY OFFICER WILL BE TO SELECT OR REPLACE THE EXEC CAPTAINS.
- IF ANY CAPTAIN WISHES TO STEP DOWN, THEY REQUIRE OFFICIAL LEAVE FROM THE ADMIRAL TO BE EXCUSED FROM THEIR POSITION. SIMILARLY, THE ADMIRAL HAS SOLE POWER TO ADD, REMOVE, OR REPLACE ANY LEADERSHIP TEAM MEMBER AT ANY TIME.
- THE CAPTAINS WILL BE RESPONSIBLE FOR EXECUTING NON-PROFIT STATUS FOR MAG BY 12/31/2020.



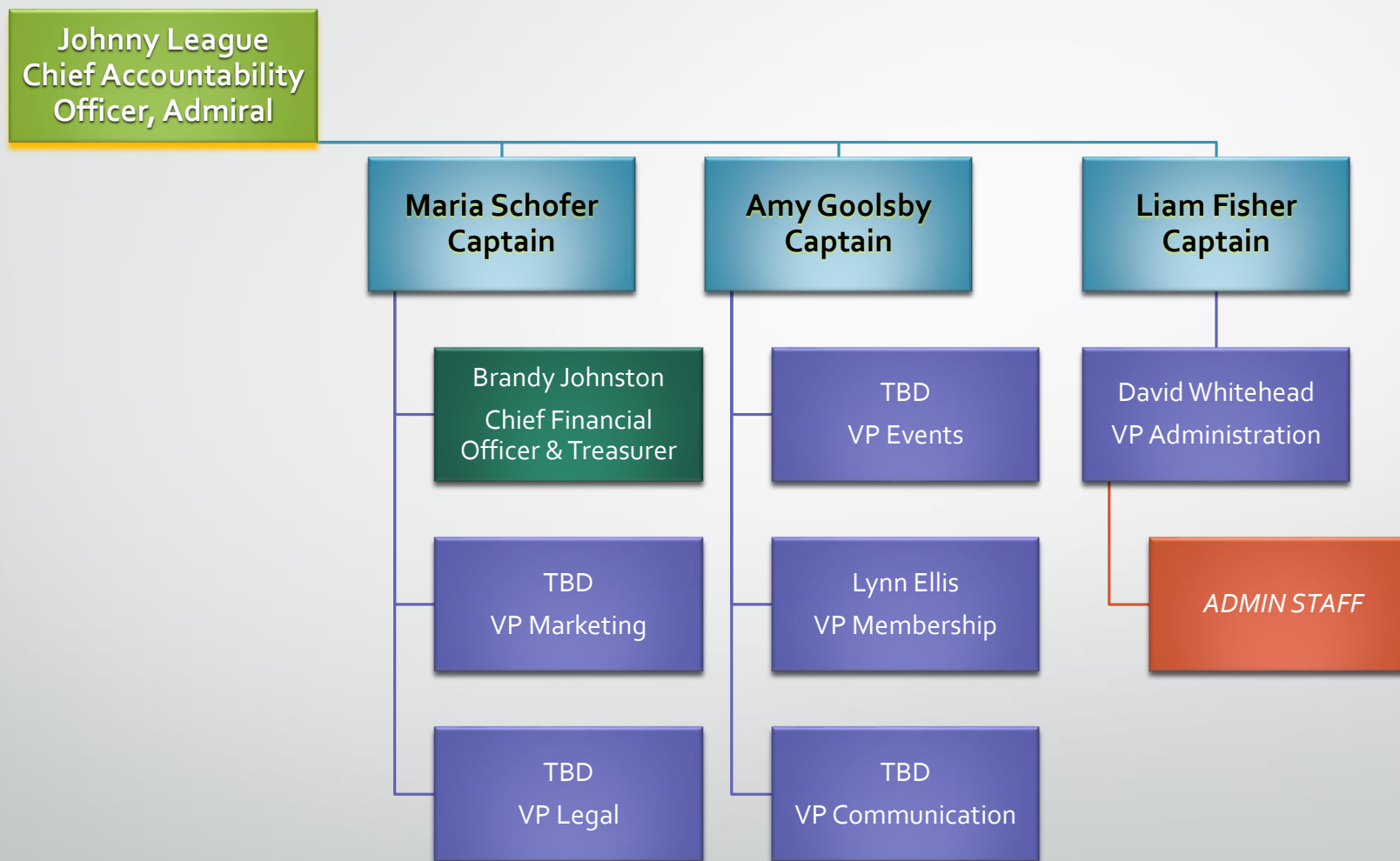


Metro Atlanta Geeks Organization Charts
